

國立臺灣師範大學「願景工程獎助學金」設置辦法

104 年 10 月 15 日修正通過

一、宗旨：

為獎助本校家境清寒學生，安心就學、努力向上，以期未來回饋社會，特訂定本辦法。

二、獎助對象：本校大學部在學之清寒學生。

三、獎助名額及金額：

每學期暫定獎助 20 名，每名獎助 2 萬元，共獎助 40 萬元整。

四、申請資格：

- (一) 本校低收入戶、中低收入戶、家境清寒或一年內家庭突遭變故之大學部在學學生，以繳交當學期學雜費有困難者為優先。
- (二) 前一學期學業成績七十五分以上者。
- (三) 當學期不得兼領其他獎助學金。

五、申請時間及程序：

本獎助學金每學期辦理一次；申請人應於公告期限內，檢附下列相關表件逕向學務處生活輔導組提出申請：

- (一) 申請表。
- (二) 學生證正反面影本(需蓋有當學期註冊章)
- (三) 符合資格之身份證明文件(如:低收入戶、中低收入戶、清寒或突遭變故之證明)。
- (四) 上學期成績單正本。
- (五) 學習計畫一篇(簡述家庭狀況、獎助學金運用計畫、未來生涯規劃等)。

六、獲獎學生名單需提供捐款人備查，並於當學期結束前繳交獎助學金獲獎心得一篇。

七、審查程序：由學務處生活輔導組按申請學生家庭狀況審核後公告之。

八、本辦法經捐款人同意後由生輔組公告實施，修訂時亦同。

Regulations for National Taiwan Normal University Vision Project Scholarship

Amended on October 15th, 2015

1. Purpose

The Vision Project provides scholarship for students in poverty to further their studies.

2. Undergraduate students of National Taiwan Normal University who are in poverty are eligible to apply for the scholarship.

3. Quota of Scholarships and Amounts

The quota of scholarships per semester is 20. The amount of scholarships for each recipient is 20,000 NT dollars. (total amount of scholarships is 400,000 NT dollars.)

4. Eligibility

(1). Low income and middle income undergraduate students, undergraduate students in poverty, and undergraduate students who encounter family emergencies within the year and have difficulty paying tuition for the upcoming semester.

(2). Score of 75 or above in the preceding semester

(3). Applicants must not apply for other scholarships.

5. Application

The scholarship is open for application every semester. Applicants shall submit the following document to the Center of Student Assistance.

(1). Application form

(2). Photocopy of the front and the back of Student ID

(3). Financial status certificates

(4). Official transcript of the preceding semester

(5). Study plans

6. Scholarship recipient list shall be submitted to the donors for reference. Scholarship recipients shall submit reports by the end of the semester.

7. Examination Process:

The Center of Student Assistance will examine the application based on applicants' family backgrounds and promulgate the result.

8. The regulation and the amendment shall be promulgated by the Center of Student Assistance upon approval of donors.
